1. INTRODUCTION

1.1. Imaging flight

The HyMountEcos APEX imaging flight was performed on 10/09/2012, at two different flying heights: 5750m and 6065m.

Image capture times range from 10:35 till 14:13 local time.




Figure 2: BRDF flight lines

15 "regular" flightlines were acquired, and 4 additional "BRDF" flightlines, as shown in Figure 1 and Figure 2.

1.2. Data set

The dataset will be delivered in multiple steps.

In a first delivery the radiance cubes (i.e. radiometrically calibrated data) will be provided to the user, together with their corresponding spectral properties files and georeferenced quicklooks. In the second and following deliveries the geometrically and atmospherically corrected cubes will be

provided to the user.

1.2.1. Delivery1: radiance data

In a first delivery, an external harddisk (VITO property) has been handed over to the Polish user, and the data has been copied onto an external harddisk of the Czech user.

1.2.1.1. Radiance data

The data set contains 19 flight lines in total, 15 "regular" flight lines and 4 "BRDF" lines.

To limit the size of the raw data files onboard, it was decided to split the dataset in 4 parts, further referenced as HYME1, HYME2, HYME3 and HYMEB.

HYME1 consists of 6 flight lines, numbered a01, a03, a05, a07, a09 and a11.

HTME2 consists of 6 flight lines, numbered a01, a03, a05, a07, a09 and a11.

HYME3 consists of 3 flight lines, numbered a01, a03, a05.

HYMEB consists of 4 flight lines, numbered a01, a03, a05 and a07.

Because the large amount of scanlines per flight line, it was decided to split each single flight line in parts, to ease the file handling afterwards.

There is an overlap of 200 lines between two consecutive flight line parts.

The table below provides the link between the flight lines as shown on Figure 1 and Figure 2, and the actual file naming of the radiance cubes.

Data is delivered in HDF5 file format.

Each HDF5 file contains both the non-georeferenced and the georeferenced (geographic coordinates, height wrt WGS84 ellipsoid, DEM=SRTM) radiance cubes, the image geometry and some additional metadata.

For the radiance data in the HDF5 files the central wavelengths for pixel 500 as determined during on-ground calibration measurements at the CHB are given.

To allow the user to extract the information from the HDF5-files, the "HDF5Reader" tool was delivered, together with a sample batch-file. Running the tool with the "–h" option shows all possible extraction options.

1.2.1.2. Spectral properties files

The names of the spectral properties files correspond to these of the HDF5 files, e.g. HYME1120910_a01r_**v2**_Part_0_SpectralProperties.xml.

For each band, the central wavelength and FWHM is given, together with 5 parameters to allow for spectral smile correction.

For more information on how to apply these parameter, refer to section 2.2 "Spectral smile".

1.2.1.3. Quicklooks

The delivered quicklooks are georeferenced using the SRTM DEM, output is in geographic coordinates (latitude, longitude) and height wrt WGS84 ellipsoid.



1.2.2. Delivery2: reflectance data for the Czech Republic

For the second delivery, data has been made available to the user through the APEX FTP-server. Account details have been provided to the user by e-mail.

1.2.2.1. Reflectance data

The data set contains 7 flight lines, that have been atmospherically and geometrically corrected. Furthermore, the spectra have been smoothed and resampled to the wavelengths, as measured during the sensor spectral calibration on the Calibration Home Base (CHB).

The delivered flight lines are: HYME1 a07, a09 and a11 HTME2 a01 and a03 HYME3 a03 and a05

Data is delivered in ENVI file format, i.e. 27 pairs of *.img and *.hdr files. The naming of the delivered reflectance cubes is given in the table below:

1.2.2.2. Spectral properties files

During atmospheric processing of the HYME data, VITO has added an additional atmospheric feature in the spectral smile detection module. This results in slightly different smile correction parameters (to be found in the *SpectralProperties.xml files). Therefore, the updated spectral properties files are included in delivery 2. Note that the version of the files has been updated from v2 to v3, e.g. HYME1120910_a01r_v3_Part_0_SpectralProperties.xml.



1.2.3. Delivery 3: reflectance data for the Czech Republic - Poland border area

For the third delivery, data has been made available to the user through the APEX FTP-server. Account details have been provided to the user by e-mail.

1.2.3.1. Reflectance data

The data set contains 4 flight lines, that have been atmospherically and geometrically corrected. Furthermore, the spectra have been smoothed and resampled to the wavelengths, as measured during the sensor spectral calibration on the Calibration Home Base (CHB).

The delivered flight lines are: HYME1 a01, a03 and a05 HTME2 a05

Data is delivered in ENVI file format, i.e. 15 pairs of *.img and *.hdr files. The naming of the delivered reflectance cubes is given in the table below:

2. APEX PROCESSING

This sections describes shortly the several calibration and processing steps performed on the acquired APEX image cube.

2.1. Radiometric/spectral and geometric Calibration

The APEX radiometric, spectral, and geometric calibration is performed by means of calibration cubes generated from data measured and collected on the APEX Calibration Home Base (CHB) hosted at DLR Oberpfaffenhofen, Germany (Gege *et al.*, 2009). This calibration is performed before and after each flight season and generates the level 1 APEX data.

However, some radiometric miscalibrations are known to exist in the first blue bands, in the SWIR spectral band region around 1020 nm and at the end of the SWIR detector.

Currently, the artifacts in the SWIR are corrected for by vicariously retrieved gain coefficients based on the metadata (ground reflectance spectra) provided by the user. A vicarious adjustment is also performed for blue bands.

Furthermore, the first 2 blue and the last 5 SWIR bands should be treated with care by the user.

2.2. Spectral smile

APEX is known to have some smile effects, i.e. the central wavelength depends slightly on the column pixel location. Furthermore, due to spectral instabilities of APEX caused by pressure and/or temperature variations, an in-flight spectral wavelength shift analysis is performed on the basis of atmospheric absorption features to reassign new central wavelengths to each pixel.

This method is used to generate the *SpectralProperties.xml files delivered to the user.

On the basis of this file the user can calculate the central wavelength for each pixel (or column of detector array), as follows :

Note that for the delivered **reflectance** cubes, the ENVI header-file contains the wavelength of pixel 500, spectral resampling to this wavelength was performed!



2.3. Geometric correction

The geometric correction is performed by VITO's own developed C++ module and is based on direct georeferencing. Input data from the sensor's GPS/IMU, boresight correction data and a user-specified DTM/DSM are further used during the geometric correction process. Finally the data are projected to UTM (WGS84, zone 33N). Note that the output resolution was not forced to a particular value, thereby causing slight differences in the observed pixel size of the images.

2.3.1. Delivery2: using DTM for the Czech Republic

VITO received from the Czech user 834 DTM-tiles (ASCII), converted and merged these into the so-called "DTM_CzechRepublic_HYME" DTM.

This DTM has been used in the geometric correction of the dataset for delivery2.

As can be seen from the figure below, also a part of Poland is included in the DTM:




Figure 3: DTM_CzechRepublic_HYME extent

It was agreed with the Czech user only to process the APEX data that falls completely within the Czech part of the DTM. This is the reason why in delivery2, only a subset of the flight lines has been delivered. Figure 1 "Regular flight lines" and Table 1 "Radiance dataset file naming" provide a visual overview of which flight lines fall within the DTM, the actual list is provided in Table 2 "Delivery2 reflectance cubes file naming".






Figure 4: DTM_CzechRepublic_HYME vs APEX flight lines

From Figure 4 it can be seen that the image parts of flightline HYME1 a05 cross the DTM-border, and hence have not been included in the delivery.

Flightline HYME1 a07 only slightly crosses the DTM-border in the upper-right corner, and has been included. Small artefacts are observable in part0 of this flight line, and data of this image should be treated with care by the user!

2.3.2. Delivery3: using DTM for the Czech Republic - Poland border area

Upon request of the Czech user, also the images crossing the border between the Czech Republic and Poland are delivered.

The delivered images are listed in Table 3 "Delivery3 reflectance cubes file naming".

These images show obvious artifacts, due to missing DTM-data for the polish side, and data should be treated with care by the user!



2.4. Atmospheric correction

The atmospheric correction of the acquired APEX data is performed by the CDPC (Biesemans *et al.*) with the MODTRAN4 radiative transfer code following the algorithms given in de Haan *et al.* (1991) and de Haan and Kokke (1996) and taking into account the in-flight determined central wavelengths for each pixel (column) (i.e. smile aware atmospheric correction).

2.5. Smoothing

Wavelength dependent spectral smoothing of the data is performed to remove noise and spikes remaining after atmospheric correction.

2.6. Wires

Wires were placed on the entry slit to observe spatial shifts. In the delivered dataset wires are interpolated during the processing. Depending on the geometric shifts apparent on the flight level of this data cube, some remaining wire residuals may exist. Some linear artefacts due to interpolation may exist. The across track wire positions are: 336-337 and 676-677, the interpolated region currently encompasses a buffer of 1 pixel around the wire positions. Pixels in the interpolated wire region should be treated with caution.

2.7. Known issues

Residual along track striping

APEX is a pushbroom instrument and hence technologically prone to striping artefacts. Most of the striping is removed during radiometric calibration and destriping before atmospheric correction. However, some residual striping, occasionally at lower spatial frequency may appear.

Residual across track striping

Some minimal across track striping may be observed in a limited number of bands.

Image crispness

Spatial misregistration correction can lead to loss of information and according visual fuzziness due to spatial resampling.

• Radiometric artefacts

Some radiometric miscalibrations are known to exist in the spectral band region 1020nm ±2 bands and spatial sample positions 319-324 as well as in the 1030nm region for all across-track positions. Pixels contained within the above mentioned spatial-spectral regions have been corrected for these artefacts but should be treated with care in this processing version.

Directional effects

The data are known to exhibit spectro-directional effects which have not yet been corrected for. These natural effects are known to affect information extraction routines in shaded and sloped areas of the imaged scene.
